Northern York County: In the northern part of the county, Fairview Township has a heavy concentration on suburban neighborhoods, providing housing for those who work in and around Harrisburg. Options include old farms, small town dwellings, and even new developments.

South Western York County: The South Western part of the county includes the Hanover area which is the County's second largest population center and a strong presence of retail and manufacturing industries. Hanover is a designated historic district, and also recently received its Main Street Designation from the Pennsylvania Downtown Center. Also in the region is Codorus State Park, a 3,500 acre park with boating, camping, swimming, and hiking.

Greater York: Most of the County's population is located in the suburban areas around the City. You will find plenty of housing options, including single wooded lots, middle-class neighborhoods, and upscale communities. The townships and boroughs in this region have seen increased population and new development. Great examples are Manchester Township, Dallastown, and Red Lion.

City of York: Downtown York offers a variety of urban living options from new condos, to lofts, to the fabulous 3 story brownstones. In downtown York, you can live, work, and play.

> South Eastern and South Central York County: Southern York County is the place to go for a rural and small town feel without sacrificing the career opportunities of a major metropolitan region. This area sits between York City and Baltimore, and people who live here enjoy an easy commute to both. Housing opportunities include 18th century farms and white picket fence neighborhoods just outside towns like Shrewsbury, Stewartstown, and New Freedom.





Hanover, Pennsylvania is known by many as the snack food capitol of the United States. Hanover has been featured multiple times on the Food Network. It is home to UTZ Quality Foods and Snyder's-Lance and in nearby areas there are others including Wolfgang Candy, Martin's Potato Chips, Hershey Foods, Gibbles Potato Chips and many others. Most of these factories give free tours.

Hanover is also the seventh largest retail area in the state of Pennsylvania. A major retail area in the greater Hanover region is along Eisenhower Drive, known as "The Golden Mile."


Hanover's Farmers' Market in the Market House is open Saturday's from 6:00 a.m. till noon. The market features fresh baked goods, quality meats, vegetables, fish and fruits. In addition to a wide variety of foods, the market is complemented with an array of local crafts and unique merchandise displayed with Hanover's German heritage in mind.

Kids Kingdom Creative Playground is located in the Penn Township's community park on Grandview Road. Penn Township Community Park is a total of 30+ acres, and has facilities for baseball, soccer, beach volleyball as well as pavilions and tables for picnickers.

The Amish Markets of Hanover is an upscale farmers market with all of the traditional vendors you would expect to see at an Amish Market – and so much more. When you visit the market, you'll be supporting local farmers, craftsman, and artisans while discovering exceptional values on unique, hand crafted items in a unique market ambience. The 52,000 square foot indoor market is open Thursdays, Fridays, and Saturdays year-round.

During the American Civil War, the Battle of Hanover was fought on June 30, 1863. Union cavalry under Judson Kilpatrick encountered Confederate cavalry under J.E.B. Stuart and a sharp fight ensued in the town and in farm fields to the south, particularly along Frederick Street. The inconclusive battle delayed the Confederate cavalry on their way to the Battle of Gettysburg. Three days before the battle, another detachment of Virginia cavalry had briefly occupied Hanover, collecting supplies and horses from local citizens.

Eichelberger Performing Arts Center is part of The Eichelberger Building, which is listed on the National Register of Historic Places. Captain Eichelberger constructed the Eichelberger Academy building in 1896 and the Glenville Academy was moved to the building. In 1991, the building no longer served as a school and was sold to a developer. The developer renovated the facility into a series of professional offices. In 1997, the remaining space including the theater was renovated into what is now known as the Eichelberger Performing Arts Center.


Codorus State Park





The closest airport is Hanover Airport 6W6. This airport sits on 105 acres and is located in Adams County PA. The airport is privately owned, but open to the public.

Lincoln (Red) Line: Featuring a historic trolley replica, the Lincoln Line provides service daily to the Gettysburg National Military Park Visitor Center, The Outlets Shoppes at Gettysburg and the Eisenhower Complex. Trips from The Outlet Shoppes at Gettysburg travel along Steinwehr Avenue and trips from Eisenhower Complex travel along Baltimore Pike.

rabbittransit Route 16: Provides weekday service between downtown York, Spring Grove and downtown Hanover via West Market Street and Route 116. This trip also meets Routes 20N, 20S, and 22N at the downtown Hanover stop.

rabbittransit Route 20N - Provides weekday and Saturday service from Hanover Square to North Hanover via Kindig Lane and Carlisle Street. Destinations along the way include Guthrie Memorial Library, Hanover Hospital, Utz, North Hanover Mall, Gateway Hanover, Hanover Crossing and Penn Township Industrial Park. This trip also meets Routes 16, 20S, and 22N at Hanover Square.

rabbittransit Route 22N - Provides weekday and Saturday service from Hanover Square to North Hanover via Carlisle Street. Destinations include Guthrie Memorial Library, Hanover Hospital, North Hanover Mall, Gateway Hanover, Hillside Medical Center, and Penn Township Industrial Park. This trip also meets Routes 16, 20N, and 20S at Hanover Square.






